

# POLAROUND INTERNATIONAL INSTANT WEEKEND

## Competition regulations

### **Point 1**

#### **Organizers**

The Photographic Association *Officina Istantanea* announce the photographic competition *Polaround - International Instant Weekend*.

### **Point 2**

#### **Aim of the competition**

The competition aims to give prizes for the best photos on each subject presented during the eight (8) hours of the marathon and the main prize to the person who develops best all of the eight set subject. There will be other additional prizes.

### **Point 3**

#### **Principles of the competition**

The *Polaround – International Instant Weekend* competition will be carried out as a photographic marathon. At the end of the competition only photographs with instant development film (IMPOSSIBLE, Fuji, Polaroid) will be considered valid and those taken during the available time of the competition. The organization relies on the good faith of the participants. Every participant will be allowed eight (8) hours to produce six (6) photos on the six (6) set subjects. Only one photograph per subject is allowed. Participation in the competition is dependent on the presenting of the shots produced.

### **Point 4**

#### **Participation**

Taking part in the competition is open to all adults or people under 18 if accompanied by parents for the whole duration of the event. Enrolments are only valid if they are made personally (and for under 18s if accompanied by parents). It is not necessary to take part in all the subjects, to be admitted to the final judging; you can also take part with single objects. The most important prize however will be presented to the person who best develops all six (6) of the set subjects.

### **Point 5**

#### **Enrolment and participation fees**

Participation in the competition is conditional upon enrolment and payment of the fee. It will be possible to enrol on the actual day of the marathon from 9.00 until the start of the competition. To enrol for the photographic competition you must pay the amount of enrolment fee. The fees for taking part are as follows: *free* for members of *Officina Istantanea*, 10.00 euro for non-members. The cost of films and photographic equipment is not included in the participation fee.

### **Point 6**

#### **Refunds**

Under no circumstances will the organizers refund the enrolment fee.

### **Point 7**

#### **Equipment**

Every participant must provide his own photographic equipment, camera and films. To guarantee that the procedure of the jury is carried out in the correct way with the prize giving in view the make of the films must not be displayed in any way or rendered recognizable. The organizers will have available some Polaroid cameras for those not in possession of one who specify this in the email for pre-enrolment and would like to be acquainted with the instant photo. The availability of cameras cannot be guaranteed for all

#### **Point 8**

##### **Date and place of the competition**

The competition will take place in Trieste on Saturday 26 April from 10.00 to 19.00. The point of departure of the marathon will be *The Art Photo Gallery, in Via Diaz 22/c*. The prize giving will take place on Sunday 27 April at 7.00PM at the same place.

#### **Point 9**

##### **Consignment of the photo entries**

Consignment of photo entries will be at *The Art Photo Gallery, in Via Diaz 22/c*, from 19.00 to 19.30, or earlier for anyone who finds it necessary.

#### **Point 10**

##### **The responsibility at the participants and the organizers**

The participants are responsible for the photos they take; if a signature of acquittance is necessary, they must arrange it themselves to their satisfaction. The participants should be aware that their photos/picture are protected by the right of ownership and it is necessary to obtain the permission of the owner of the rights.

The management is not responsible for the behaviour of the participants. The event takes place in the city centre; therefore the participants are expected to behave in a reasonable and responsible manner and avoid causing any disturbance of normal street movement and city life.

The management reserves the right to cancel or postpone the marathon in the case of any violent disturbance/excessive force.

#### **Point 11**

##### **Returning of the photos**

It is duty of the organizers to return the photos. The photos will be returned as they were given for the participation in the competition without any actual frames used for display in the exhibition. The winners will be notified by telematic means or by phone for the return of the photos and will be asked to provide an address to send them back to. For anyone who does not provide any address or if it proves impossible to contact the winners, their photos will be dealt with accordingly and will go into the archives of Association *Officina Istantanea*. The management will not be hold responsible for the eventual loss of photos. For non prize winners however it will be possible to pick up their photos on the day of the prize giving or contacting Association *Officina Istantanea* within 3 months from the date of the marathon. Should such photos not to be collected within that time, they will be dealt with accordingly and will go into archives of Association *Officina Istantanea*.

#### **Point 12**

##### **Intellectual property of the photos and handling of works**

All participants have the full right of ownership and use of the photos made for the event of the competitions according to code of intellectual property. The participants agree to use of their photographic pictures for display and promotion for future initiatives of the organizers. The photos used will clearly indicate the name of photographer but without any commercial value only the right of the author. The management will not be held responsible for eventual theft or damage of the works during the period of the exhibition.

#### **Point 13**

##### **Jury**

The judgment of the jury is final and cannot be challenged. The jury can decide not to offer all the prizes. The jury furthermore reserves the right to mention worthy works.

#### **Point 14**

##### **Prizes**

The prizes for the winners will be offered by the management and sponsor of the event. The management will not offer any money prizes. The prizes cannot be converted into money or substituted by any other types of goods or services. The results will be communicated and made public and winners will be advised by telematic means or by phone. The prizes can be claimed on the day of the or in the three months following in the way and at the places detailed by the management and always notifying the winners. There will be no notification by post.

The organization is giving away discount coupons offered by the sponsors, cameras and instant films and the setting up of a collective exhibition for the winning photos.

## INFORMATION AND AGREEMENT ON THE HANDLING OF PERSONAL DATA

With reference to Article 13 D.lgs. 196/2003 relative to the personal details supplied to the association Officina Istantanea (from now referred as the organizers) for the competition Polaround the relevant information is as follows:

- a) Information details received. The personal details by the organizers are only those supplied by the person completing the registration form for the competition.
- b) for interest in the next editions of Polaround of interest of the material of a communicative or interactive nature. The personal details will be handled and kept by the organizers as legally required until the end of the aforementioned event and for any future occurrence unless the express interests of the participant state otherwise.
- c) Handling procedure. Any handling action or actions are fulfilled in accordance with article 4 comma 1° D.lgs 196/2003 using manual or computer method; the details supplied may be kept on magnetic or paper material as required by legal safety. The personal details supplied may be handled for the previously mentioned event also using SMS and/or other computerized methods as automatic transmission or communication. The organizer must not make any inaccuracies in the personal details or until any inaccuracy has been corrected.
- d) Giving details. The participant is at liberty to give what details he wishes but must supply the information necessary in accordance with regulations and statutory requirement.
- e) Refusing to give personal details. Refusing to give personal details renders it impossible to take part in POLAROUND.
- f) Rights of the interested person. Art. 7 D.lgs 196/2003 gives the participant the right: to obtain information about the origin of the personal details, to obtain information as to the purpose and procedure of the service, to obtain information in how the service may be effected by use of electronic instruments, to obtain information of subjects to which the personal details can be communicated or conveyed by a representative who has given the charge of responsibility, to obtain updates or corrections which may need to be added to the details, to obtain a cancellation, an anonymous transformation stopping the use of data for a violation of the law, including cases where the aims are not the same as those for which the data was collected and subsequently used, to obtain a statement in the case of events described in the two previous paragraphs coming to light even if the contest and their details have been made known except in the case that such procedure becomes impossible or out of proportion because of the right of tutelage, to oppose completely or in part for legitimate reasons the use of the personal data even if the purpose of their collection was relevant, to oppose the use of personal data to be used in published material or promotional purposes. The details supplied can be verified on request from the Association Officina Istantanea, and can be updated and/or corrected by means of letter or email sent to [info@officinaistantanea.com](mailto:info@officinaistantanea.com) using the same means you can ask for the personal details to be cancelled. In the case of cancellation request of personal details supplied made to the organizers, no further advice or communication is required. Such a cancellation in the case of cancelling of details and reports, will take immediate effect.

With reference to the above mentioned legal act the procedure of personal details is carried out by the Association Officina Istantanea and with reference to the art. 13 D.lgs 30 June 2003 n.196.
