Competition regulations

Point 1

Organizers

The Photographic Association Officina Istantanea announces the fifth edition of the photographic competition "POLAROUND -International Instant Weekend".

Point 2

Aim of the competition

Participants will be given of the themes to be developed with instant-developing film. The competition aims to give prizes for the best photos on each subject presented during the twenty four (24) hours of the marathon and the main prize to the person who develops best all of the five set subject. There will be other additional prizes. The jury reserves the right to award additional prizes in the event of particularly creative or technical merit job. This year, there are also the Alinari Image Museum Prize for the work that will show more sensibility and photographic culture, and the Young Talent Instant Prize, reserved for participants under 18 years.

Point 3

Principles of the competition

The "POLAROUND – International Instant Weekend" competition will be carried out as a photographic marathon. At the end of the competition only photographs with instant development film (IMPOSSIBLE, Fuji, Polaroid) will be considered valid and those taken during the available time of the competition. The organization relies on the good faith of the participants. Every participant will be allowed twenty four (24) hours to produce five (5) photos on the five (5) set subjects. Only one photograph per subject is allowed. You will also deliver a single photograph, giving up the chance to win the first prize and category prize for each theme is not developed. The first prize will be awarded to those who develop the best set of five (5) photos. The award is subject to the delivery of shots taken. Participation in the competition is dependent on the presenting of the shots produced.



Point 4

Participation

Taking part in the competition is open to all adults or people under 18 if accompanied by parents for the whole duration of the event. Enrolments are only valid if they are made personally (and for under 18s if accompanied by parents).

Point 5

Enrolment and participation fees

Participation in the contest is free and reserved for members who paid the membership fee for the year 2017. Anyone who wants to participate in the competition, will join Officina Istantanea, upon payment of the membership fee of 15 euro, within Friday 5th May 2017 at the opening of the photographic marathon.

Point 6

Refunds

Under no circumstances will the organizers refund the enrolment fee.

Point 7

Equipment

Film or photographic equipment are not included. In order to participate in the competition, you can contact the organization to request a loan of an instant camera and its user information, as long as availability, The availability of cameras cannot be guaranteed for all the requests. Point 8

Date and place of the competition

The competition will take place in Trieste on Friday 5th, Saturday 6th and Sunday 7nd May 2017. The opening of the competition will be on Friday 5th May, 07:00 pm at Eppinger Caffè, in via Dante 2/b - 34122 Trieste, where the organization will announce the subjects to develop in the photographic marathon.

On Saturday 6th May, participants will deliver their photos, from 06:00 pm to 08:00 pm at Eppinger Caffè, in via Dante 2/b. The prize giving will take place on Sunday 7nd May, at 07:00 pm at the same place. There will be an exhibition of the photos of all participants.

Point 9

Consignment of the photo entries

Consignment of photo entries will be Saturday 6th May at Eppinger Caffè, in via Dante 2/b, from 06:00 pm to 08:00, or earlier for anyone who finds it necessary. To guarantee that the procedure of the jury is carried out in the correct way with the prize giving in view the make of the films must not be displayed in any way or rendered recognizable.

Point 10

The responsibility at the participants and the organizers

Participants are responsible for the photos they take; if a signature of a quittance is necessary, they must arrange it themselves to their satisfaction. The participants should be aware that their photos/picture are protected by the right of ownership and it is necessary to obtain the permission of the owner of the rights. The management is not responsible for the behavior of the participants. The event takes place in the city center; therefore the participants are expected to behave in a reasonable and responsible manner and avoid causing any disturbance of normal street movement and city life or causing damages to people or things. The management reserves the right to cancel or postpone the marathon in the case of any violent disturbance/excessive force.

Point 11

Returning of the photos

Photos will be returned as they were given for the participation in the competition without any actual frames used for display in the exhibition. The management will not be hold responsible for the eventual loss theft or damage of the photos. The works will not be shipped and can be withdrawn at the end of the prize or any subsequent meetings organized by prior request. If photos will not be collected within 31st December 2017, will go into archives of Association Officina Istantanea.

Point 12

Intellectual property of the photos and handling of works

All participants have the full right of ownership and use of the photos made for the event of the competitions according to code of intellectual property. The participants agree to use of their photographic pictures for display and promotion for future initiatives of the organizers. The photos used will clearly indicate the name of photographer but without any commercial value only the right of the author. The management will not be held responsible for eventual theft or damage of the works during the period of the exhibition.

Point 13

Jury

The judgment of the jury is final and cannot be challenged. The jury can decide not to offer all the prizes. The jury reserves the right to make any special mention or award additional prizes in case of particularly creative or technical merit jobs.

Point 14

Prizes

Prizes for the winners will be offered by the management and sponsor of the event. The management will not offer any money prizes. Prizes cannot be converted into money or substituted by any other types of goods or services. The results of the photo competition will be announced and made public and the winners will be notified via computer and / or telephone. Prizes can be collected on the day of the prize or within three months in agreement with the organization. Prizes will not be sent by mail. The organization is giving away discount coupons offered by the sponsors, cameras and instant films and the setting up of a collective exhibition for the photographs of the participants.

INFORMATION AND AGREEMENT ON THE HANDLING OF PERSONAL DATA

With reference to Article 13 D.lgs. 196/2003 relative to the personal details supplied to the Association Officina Istantanea (from now referred as the organizers) for the competition Polaroid the relevant information is as follows:

a) COLLECTED DATA. The personal data collected by the organizers are only those supplied by the person completing the registration form for the photo competition. They will be retained the fewest possible types of data for the service.

b) PURPOSES OF THE PROCESSING. Personal, common and sensitive data will be processed and used for the accounting and administrative management of the service, including surveys and records, the performance of contracts, the fulfillment of obligations under applicable laws, regulations or policies Community, provisions issued by authorities entitled by law and by the vigilance and control, fulfillment of contracts to suppliers, for the transfer of goods and services as well as for the fulfillment of statutory obligations, contractual and regulatory as part of the Association Officina Istantanea. Because the Association aims the social purpose of carrying out activities to spread the photographic culture, through contacts between people in organizations and associations, Officina Istantanea may use the data provided to sending information about the

activities and initiatives organized by the Association in the future. Furthermore, the organizers will be able to use these data for: sending informative or advertising material and make communications to the person, also interactive communications, on upcoming editions of Polaround. The data provided will still be processed and stored by the organizers as provided by the regulations for the purposes stated above and for future relationships which may be established, unless the person concerned expressly withdrawing authorization for treatment.

c) HANDLING PROCEDURE. Any handling action or actions are fulfilled in accordance with article 4 comma 1° D.lgs 196/2003 using manual or computer method; the details supplied may be kept on magnetic or paper material as required by legal safety. The personal details supplied may be handled for the previously mentioned event also using SMS and/or other computerized methods as automatic transmission or communication. The organizer must not make any inaccuracies in the personal details or until any inaccuracy has been corrected.

d) GIVING DETAILS. The participant is at liberty to give what details he wishes but must supply the information necessary in accordance with regulations and statutory requirement.

e) REFUSING TO GIVE PERSONAL DETAILS. Refusing to give personal details renders it impossible to take part in Polaround.

f) RIGHTS OF THE PERSON. Art. 7 D.lgs 196/2003 gives the participant the right: to obtain information about the origin of the personal details, to obtain information as to the purpose and procedure of the service, to obtain information in how the service may be effected by use of electronic instruments, to obtain information of subjects to which the personal details can be communicated or conveyed by a representative who has given the charge of responsibility, to obtain updates or corrections which may need to be added to the details, to obtain a cancellation, an anonymous transformation stopping the use of data for a violation of the law, including cases where the aims are not the same as those for which the data was collected and subsequently used, to obtain a statement in the case of events described in the two previous paragraphs coming to light even if the contest and their details have been made known except in the case that such procedure becomes impossible or out of proportion because of the right of tutelage, to oppose completely or in part for legitimate reasons the use of the personal data even if the purpose of their collection was relevant, to oppose the use of personal data to be used in published material or promotional purposes. The details supplied can be verified on request from the Association Officina Istantanea, and can be updated and/or corrected by means of letter or email sent to info@officinaistantanea.com, using the same means you can ask for the personal details to be cancelled. In the case of cancellation request of personal details supplied made to the organizers, no further advice or communication is required. Such a cancellation in the case of cancelling of details and reports, will take immediate effect.
